## 2. Mission Statement


To build human and institutional capacities through the application of the best practices in Project Planning and Management, Information Technologies, Research and Publishing.

Project Coordinator is directly under the Projects Director and coordinates all the projects including Development Projects, Information Technology, Research and Publishing Projects. Under each of the projects, there is a training component.
